<b>Data Recipients</b>	We may share your personal data with other recipients, if such an obligation arises from the law. As a general rule, we do not transfer data to third countries. However, should such a transfer occur, we will comply with all the requirements set out in Chapter V of the GDPR.				
<b>Retention Period</b>	Your personal data will be processed as long as you remain interested in the content we present on your profile. You have the right to object to the further processing of your data at any time. If any claims are exercised, we will retain your data until the expiry of their limitation period.				
<b>Voluntary Data Provision</b>	Your data are given freely by you.
